Student Indemnity Agreement

In this agreement the following words shall respectively mean:

- "The Student" the person named as such on this enrolment form on this paper (above)
- "The Organiser" Graceland Institute (any campus or organisation associated with a Graceland Institute school, Registered Training Organisation or company), Graceland Institute and any teachers, lecturers, instructors, directors, officers, managers, advisors, employees, agents, licensees, subcontractors, subsidiaries, holding companies, associates and assignees, or any person associated with the company in any way; the course participation venue, company in control of the venue or any company or person authorising the use of the training venue, its directors, officers, managers, advisors, employees, agents, licensees, subcontractors, subsidiaries, holding companies, associates and assignees or any person or company associated with the company or person in any way.
